# **Basic Requirements**

# **Eligibility:**

- Must be a U.S. Citizen
  - Ownership 51%
- Management and Control Full Time
- Size Small Based on NAICS code NAICS.gov
  - Potential for Success 8(a) break even
- Good Character Not Bankrupt, Not Felon, Not Owe Federal Taxes
